- 1. EN 13823:2020+A1:2022 Reaction to fire tests for building products Building products excluding floorings exposed to the thermal attack by a single burning item.
- EN ISO 11925-2:2020 Reaction to fire tests Ignitability of products subjected to direct impingement of flame — Part 2: Single-flame source test.
